## Residents testify at Washington County commissioner ordinance hearing on Monday

A public hearing discussing proposed ordinances 86, 87, and 88 was held in the Vendome Events Center in Weiser on Monday afternoon. After opening remarks from Chairman Kirk Chandler, 19 Washington County residents and others were invited to testify their opinions on the ordinances. Eleven individuals expressed opinions in support of the ordinances and eight expressed their opposition. The individuals testifying involved a range of citizens including ranchers, elected officials, and new residents of the county.

One by one, names were called, and people

made their way to a podium to speak their piece.

"It is my understanding that the purpose of the elected commission of Washington County is to represent all of the citizens of the county," said Clarence Stark, a Weiser resident. "I know that is an exceedingly impossible task at times, however you must represent the desires of the majority of the electorate."

Stark, one of the eight testifiers against the ordinances, said at the hearing that it appears the proposed documents would serve only a small percentage of Washington County residents, a number specified

by earlier testifier Jeri Soulier. Soulier said 1.75 percent of residents would directly benefit from the passing of the ordinances and said she spoke with Sherriff Matt Thomas earlier in the year regarding budgetary constraints.

"I did speak with Sherriff Thomas this past spring and he said he did not have the authority, in his opinion, to enforce anything on federal ground...he does not have the manpower, lack of radio coverage, proper equipment, and budgetary limits," she said at the hearing.



## Quick thinking by von Brethorst saves the life of a young Missouri boy

On Sept. 5 over Labor Day weekend, Weiser High School graduate Brody von Brethorst helped save a young man from drowning in a Missouri lake.

Attending Missouri Valley College on a wrestling scholarship, von Brethorst said he and friends from the wrestling team went to cliff jump at Stockton Lake, a 1½-hour drive from their home in Marshall. After jumping from a 60-foot cliff several times, he and his friends took a break while a group of people wandered toward them.

“A couple kids see us jumping and they come up after we were done,” said von Brethorst.

After several jumps, an individual named Furious Laney announced he would attempt a front-flip off the cliff. Von Brethorst said that he and his friends had reservations, however Laney reassured them saying he had already accomplished the trick.

Laney jumped but over-rotated and landed the 60-foot drop into the water on his face and stomach, said von Brethorst. Already making the decision to help if something went awry, he counted three seconds before scaling down the cliff on the rope already provided for recreation.

“I counted, and nothing happened. He just disappeared into the water,” he said. “People started to panic. I saw people start jumping off their boats.”

With experience as an athlete on the

Weiser swim team, von Brethorst had confidence that he could dive deep and find the missing young man. Using goggles and a mouth breather provided by a bystander, he began searching. Seeing bubbles at the surface of the water, he dove to find Laney face-down at the bottom of the lake.

“I just grabbed him with one arm, and just kicked off the bottom,” said von Brethorst.

Once on the surface, off-duty nurses helped to lift Laney onto a boat and immediately began CPR after he was underwater for four minutes. He was then life-flighted from the boat dock to Cox South Hospital in Springfield.

Von Brethorst’s mother, Kathlene von Brethorst, said that while the experience of her son saving a person was surreal, his willingness to jump in did not surprise her. He is often quick to help when things are not right and has a decent moral compass, she said. His father’s vocation as a paramedic likely influenced his care for others and his bravery and his always attempts to keep a level head, he said.

Laney returned to school last week, and is expected to make a full recovery, said von Brethorst. Both families have been in contact with each other, keeping up-to-date and remaining informed.

“I’m just thankful I’m a solid swimmer and could pull the kid up,” said von Brethorst. “I just got lucky I guess saving him.”

# Grade school students enjoy healthy snacks

## USDA funded grant gives kids fresh fruits and vegetables give kids exposure to new foods

On Sept. 10, Idaho Superintendent of Public Instruction Sherri Ybarra announced that 118 Idaho schools will receive free, fresh fruit and vegetables per a U.S. Department of Agriculture funded grant.

“We love administering this program, and children love the wide variety of fruits and veggies,” Superintendent Ybarra said via a press release. “This is an effective, creative way of introducing healthy snack options for school-children throughout our state.”

Weiser schools Park Intermediate and Pioneer Elementary have both received the grant, beginning the program on Monday of this week.

The Weiser School District has participated in the Fresh Fruit and Vegetable Program (FFVP) for the last five years, said Food Services Administrative Assistant Jana Garrison, with Pioneer receiving the grant for five years and Park for four.

“We’re really happy to have [the students] try and taste and enjoy [the produce,]” said Garrison. “That’s the whole point – expose them to the wonderful variety of fruits and vegetables and help them to understand that’s a good way to eat; is to try a fruit or vegetable rather instead of heading for the salty sweet snacks.”

The school district has a vendor in Boise that sources the food for the program, buying local when they are able and finding fruits and vegetables ranging from varieties of apples and oranges to dragon fruit and lychee. Some foods are served based on a theme, such as the rambutan fruit served during Halloween, while others are served based on seasons, such as plums.

The food must be fresh, said Garrison, and can only be served cooked once a week.

The students receive nutritional information of the produce item and are given the opportunity to observe the food in its natural state before trying

a sliced piece. The program is volunteer based and is served during a recess time.

“I think the kids really look forward to coming down and seeing what’s new,” said Garrison. “It’s fun for them to see what the fruit looks like as a whole, rather than just when they come through lunch line they’ll see it cut up or whatever and they don’t get to see what it looked like...with the covering.”

At Park Intermediate, the program has been positive in keeping students sustained throughout the school day and maintaining focus on learning, said Principal Angie Halvorson. “Snack recess” is scheduled between 10:15 a.m. and 10:45 a.m., giving students a snack break between breakfast and lunch.

“One of the number one reasons that we have misbehavior in our classrooms is kids are hungry,” said Halvorson.

The FFVP not only gives students the opportunity to try new foods and to have a mid-morning snack, but to also foster relationships. The ladies in the kitchen serve the fresh food to the students and because there is less rush than the lunch line, there is more opportunity to chat with the students.

“There’s so much more that comes out of a program like this than just having a piece of fruit or serving of vegetables,” said Halvorson. “We are fostering that kind of communication in our building.”

The FFVP is only offered to elementary schools, grades first through six, and several elements are considered such as need and enrollment for a school to be considered for the grant.

“I’m glad that they offer these sort of grants for schools, especially children in low income areas where they just can’t afford to pick something willy-nilly and try it,” said Garrison. “But once they’ve had that opportunity, they might...not be afraid of trying something that looks odd and weird in the grocery store, because once you cut it open it’s really good.”

## Toothfully Speaking

### Diastema?

Have you ever heard of a diastema? Even though you may not have heard the word before, you have seen one and know what it is. Many famous people like Arnold Schwarzenegger, Madonna, Michael Strahan, Eddie Murphy and David Letterman all have one. Do you know what it is yet? A diastema is simply a space or a gap between teeth.

Some people like the way their teeth look with a diastema, but many people choose to close their diastema. There are three ways that a diastema can be closed; braces, a composite filling or veneers/crowns.

Braces close the diastema by simply moving the teeth closer together. The shape, size and color of the teeth are

unchanged. Braces can also fix many other bite issues.

To close a diastema with a composite (tooth colored filling) material is added to the two teeth until the gap is closed. The composite is closely matched to the color of the tooth.

With veneers/crowns the teeth are shaped, then an impression is taken and a few weeks later the veneers are cemented on. Veneers can change the size, shape and color of the teeth.

Weiser continues to be in the Orange category, down from the Red, for COVID-19 spread. To make it even better, according to my calculations, we should be moving down into the Yellow! Next week the school district will be moving from the current A/B schedule to allowing students to attend four days a week on Monday-Tuesday and Thursday-Friday. Please take extra caution to watch out for kids walking and biking. Remember not to pass a bus with flashing stop lights. Kids are hard to see sometimes and they move fast!

If you aren't already aware, Angel Wing's Network will be having the Fun Walk/Run, their main fundraiser, held virtually this year. In addition, they will be selling 100 tickets for a drawing for a Traeger pellet barbecue. You can go to their webpage to find more information.

This is a local charity doing great work helping local families deal with cancer. Angel Wings Network deserves our support.

Also be aware that there is a lot of farm equipment on the road this time of year. Please be careful and have a little patience driving on the highway and back roads.

The Weiser Recreation Department will be taking registrations for first and second grade boys basketball, the first through sixth grade girls basket-

ball clinic and scrimmage, and third through sixth grade boys youth basketball through Oct. 14. The fee is \$25 for city residents and \$30 for county. If your child does not already have a Weiser Recreation Dept. jersey, there will be a \$21 charge to purchase one.

The third through sixth grade girls youth basketball will be played after the first of the year with a registration deadline of December 9. There will be a separate fee for the girl's clinic and youth basketball.

In addition to youth basketball, the Recreation Dept. will be hosting a men's basketball league this year. Registration will be through Oct. 21, with a penalty for late registration or roster changes. The fee is \$200 per team. There will be a zero-tolerance policy for misconduct. Last year the season was cancelled due to behavior issues the prior year. Please see the Recreation Dept. for details.

The street department continues to work on East Commercial St. between East 9th and East 11th. The project is going according to schedule and should be completed by the end of the month.

Also, West Third St. at the railroad crossing will be closed the week of Oct. 5 through 9 to allow Union Pacific to completely redo the crossing. The railroad has had to repair this crossing annually because it tends to elevate itself from the road. This time they will be taking it out completely to fix the underlying problem.

America honors a brilliant woman

No other Supreme Court Justice has ever captured the heart of America the way Ruth Bader Ginsberg has. Several – Hugo Black, William Douglas, Thurgood Marshall – are remembered, but Ginsberg is the one whose image has found its way into millions of homes not only in book covers but in t-shirts, earrings, socks, action figures, and, yes, even tattoos.

Elegant praise followed Ginsberg's death on Thursday. She was "a giant in heart and spirit," "an icon of women's rights," "a warrior for gender equality."

RBG's 87 years spanned the transformation between women being "protected" by laws that considered them incapable of carrying heavy packages or serving on juries to women becoming CEOs, generals, and judges.

Ginsberg was among the first women to attend Harvard Law School, the first to be part of the Harvard

Law Review, and the first to become a tenured faculty member at Columbia School of Law.

As Cindy Jenks, president of the National Federation of Democratic Women wrote, "Justice Ginsburg was a trailblazer and a monumental jurist that will likely

never be matched in comparison to her work ethic, her wit and her dedication to fairness and justice for all persons."

Saturday, I learned that an Idahoan was the plaintiff in the first brief Ginsberg wrote for the Supreme Court. When Sally Reed's son died, both she and her former husband sought to administer his estate. Idaho law at the time stated that "males must be preferred to females" in appointing administrators. Negating that law was a first step in a long fight for gender equity.

Another early victory got a father social security ben-

efits after his wife died.

Working for the American Civil Liberty Union, Ginsburg took part in 34 Supreme Court cases and won five of the six major cases she argued before the Court.

Ginsburg had served 13 years on the D.C. Appellate Court when President Bill Clinton appointed her to the Supreme Court. She was approved by a vote of 97-3 – an amazing show of unity.

University of Miami Professor Robyn Walsh reacted to RBG's death by writing, "It says a lot about us that the loss of one voice leaves women and their allies feeling so helpless. I am grateful for RBG, her advocacy, and her strength. I'm enraged that we find ourselves here."

And women are not the only ones feeling fear and anger. As a justice, Ginsberg championed equal rights for all, including LG-BTQ individuals, persons of color, immigrants, minorities, the poor, and the ill.

The Supreme Court is scheduled to hear an argument to abolish the Affordable Care Act on Nov. 10. Even with over 40,000

new COVID-19 cases per day and seven million unemployed, a number of Republican-led states continue their efforts to destroy health care exchanges and shrink Medicaid.

Ginsberg's voice will be missed.

President Trump is not worried about angering voters by ignoring RBG's dying wish to have the appointment delayed until after the inauguration or by the hypocrisy of senators who claimed President Obama couldn't appoint a nominee because the 2016 election was only 11 months away.

But he should worry about voters' reaction if he fails to name a worthy candidate. Another Brett Kavanaugh would be the ultimate insult to RBG's memory.

Those events will unfold in time. Now is a time to enjoy basking in being part of an America that loved a brilliant woman – one admired for "her work ethic, her wit and her dedication to fairness and justice for all persons."

### Public hearing was held on proposed ordinances

Along with concerns of potential lawsuits from the federal government, the citizens testifying against the ordinances included financial concerns for taxpayers as well as a lack of manpower for the ultimate enforcement of the ordinances.

The 11 individuals that expressed their support, however, included statements encouraging counties to band together for change.

Weiser resident Jana Liyeed said she was a first responder during a recent Midvale fire and witnessed first-hand the Bureau of Land Management’s handling of fire control. Liyeed testified that she watched the BLM refuse help after ranchers and farmers offered their bulldozers and other equipment.

Idaho Representative Judy Boyle testified at the hearing that she believes the Idaho counties finding themselves in similar land issues as Washington County should support each other and together, hire a specialized attorney. She continued in her testimony to say she believes the ordinances would help all Washington County residents.

“The air, all of us breathe,” she said. “The water, all of us recreate in or we play in or we irrigate.”

Chairman Chandler closed the hearing saying all testimonies would be reviewed and agenda would be scheduled to discuss during the county commissioner meeting the following week.

“We’re here to please you and we’re pleased you’re here,” said Malay.

While the event may be downsized in order to take precautionary measures, Dominguez said that they are prepared to meet the needs of the community nonetheless.

This year, said Dominguez, families are especially in need and businesses have already proven themselves increasingly generous.

“It’s kind of a labor of love for me, and it’s a way for us to give back to the community,” said Dominguez.

Residents in assisted living facilities, senior center guests and Meals on Wheels receive a box of chocolate

Since 1992, there have been 35 districts and senators, but the Idaho Constitution permits as few as 30 and as many as 35 districts and senators, with the number determined during redistricting (the process of redrawing legislative district boundaries after a United States census). If this amendment is adopted, the number of districts and senators would be fixed at 35 and could not be changed during redistricting.

ess, because redistricting plans must comply with several legal requirements that can be in conflict with each other. For example, districts must be roughly equal in population, but must also avoid, to the extent possible, splitting up counties and communities - even though some counties and communities have significantly larger populations than others. Redistricting plans that fail to comply with all requirements can be challenged in court. By adding another fixed requirement, this amendment would make redistricting more difficult and might invite court challenges. The commission currently has the flexibility to determine the number of districts within a certain range because it is possible that a plan with 30 larger districts could better satisfy legal requirements than a plan with 35 smaller districts. The commission’s flexibility should be preserved.

2. Changes to the redistricting process should be proposed well in advance of a redistricting year, with enough time to consider all possible consequences of the change. This amendment would cause a significant change to be made right before redistricting occurs in 2021 without sufficient time to consider the consequences.

3. Reducing the number of legislative districts would mean a corresponding reduction in the number of legislators. This would reduce the size of the government and could potentially save public funds spent on legislator salaries and benefits.
